


## 4-CRAEC / 01 Meeting Call to Order

## 4-CRAEC / 07 Matters Arising out of Previous Executive Committee Meeting Minutes

## Co-opt Members from Tamilnadu and Kerala

President informed the members that based on the approval of the previous minutes, we can co-opt one member from Kerala and One from Tamilnadu as there is no representation from in EC.

## Resolution: It was unanimously resolved that two members One from Tamilnadu and One from Kerala will be Co-opted to EC

## **Status of Establishment of State Chapters**

President informed that, State Chapters have been established in various States of Tamilnadu, Kerala, Karnataka, Maharastra. He Appreciated the efforts taken by Dr.S. Chandrasekar, Vice President South in initiating the chapters in south zone

## Few Points of meeting got missed

Dr. S Chandrasekar, Vice President South raised the point that few points are missing in the previous minutes of the meeting and the meeting minutes are not as professional. The President said that since it is prepared by people who don't have expertise in preparing the professional Minutes of meting as done in many associations and requested any member to prepare the minutes of the meeting.

Mr.M S H Beg, Treasurer suggested that Dr. S Chandrasekar, Vice President South can be considered to prepare the minutes and the draft can be presented to the office bearer for approval and suggestion. Dr. S Chandrasekar, Vice President South accepted the work and said he shall try to the best of his abilities to complete the task and will be able to support for one or two minutes of the meeting.



#### 4-CGB / 8 Officers Report

#### **Report by President**

The President shared the various updates on the upcoming project and various inspections carried out by the project agencies. He also pointed out that CRA over the years was unable to show the proper documentation to the agencies like HR Policy, Fiancé Utilization Policy, Accounting statement and other documents. He also informed that a proper documentation is very essential in CRA, without which project agencies will not be convinced in allocating project. Hence a Consultant has been hired to draft the various policies required for effective working of CRA

## **Report by Treasurer**

Since the Mr.M S H Beg, Treasurer had some technical issues in presenting the accounts online, the Power point was presented by the Mr.Sandeep Rana and explained by the President. He presented that an amount of **Rs. 97761** for the month of September and **Rs.128517** for the month of October 2023 was spent towards salary, rent, consumables, and other expenses.

#### Report By Secretary General

Mr.Jitendra Sharma, Secretary, shared that the payment for the project from the Ministry of Culture for the project "Har Ghar Tiranga" and "Meri Matti Mera Desh" has been delayed as the ministry has not been allotted the fund till date. He also presented that He, President, Tressure as team met various ministries to get connected with them for the benefit of CRA. They used the Diwali as reason to meet the various ministry and greeted them with sweets.


## 4-CGB / 09 Any other Matter

#### **Report Presentation by Office Bearers Only**

Mr.Shivashankaraswamy, Joint Secretary Proposed that the Report of activities of Accounts and other events should be presented only President, Treasurer and Secretary only. Mr.Sandeep Rana is an Invited person to meeting and he cannot present the accounts on behalf of treasurer which against the MOA. He also added that in the absence or inability of the office bearers to present then, it should be presented only by the President or any other Vice President.

Mr.M S H Beg, Treasurer opined that he has authorized Mr.Sandeep Rana to present the accounts on his behalf.

Dr. S Chandrasekar, Vice President South also insisted that Mr.Sandeep Rana is taking care of CRA office and he is not a EC members and he cannot be authorized to present the activities of CRA and it is againt the MOA.



## Payment of 4 Months' Salary to Accountant

Dr. S Chandrasekar, Vice President South, Mr.Shivashankaraswamy, Joint Secretary and members questioned on payment of single payment of four months salary to the accountant.

President and Treasurer Clarified that, with margin of accounts handled for CRA, the auditor has nominated a person who visits on part time to check and maintain the accounts of CRA. The bill for payment was not raised for last four months and was paid together.

#### **Feeble Reserve Fund Position**

Mr.M S H Beg, Treasurer altered all the members that, CRA has been using the funds and no income is coming to the account. If the same continues the reserve will be exhausted and with feeble reserve meeting the day to today expenses will be difficult. Hence measures must be taken to improve the fund reserve.

#### **Enhancing the Visibility of the CRA**

Ms. Barsha Chabaria, EC Member, suggested that it is high time that CRA takes efforts to enhance the visibility of CRA by actively involving all members through national Social Media for CRA, A digital Monthly newsletters can also be released and Website can be updated. She also emphasized that, during the Samhelan held in North India more than 100+ new CR stations participated in the meeting, hence effort should be taken to bring the new CR stations to CRA there by increasing the number of members and also enhance the revenue for CRA.

The President and Members appreciated Ms. Barsha Chabaria, EC Member for bring valid points to be addressed in the upcoming days.

#### **CRA Membership Certificate and ID Cards to CR Stations**

Dr. S Chandrasekar, Vice President South suggested that CRA Membership Certificate and ID Cards are to be issued to all CR Stations, the same was issued before two tenue and only few members have the membership certificate. He also suggested that CRA should probe on the new areas of raising fund, We should not depend only on Government Agencies for project, we can try for private players also.

The President and Members appreciated Dr. S Chandrasekar, Vice President South for brining in the CRA Membership corticate to all CR stations. The President assured that efforts will be taken to send the certificate to all Members. Regarding ID Card time is required to plan, design, and execute.

Mr. Jitendra Sharma, Secretary, suggested that Digital copy of the Certificate can be sent to all members, which shall reduce the cost.



## **CRA Should Focus on Capacity Building and Other Workshops**

Mr.Sandeep Parmar, Vice President North pointed out that CRA should focus on various workshops like Capacity Building, Sustainable development and other arears where the members will have advantage in operating the CRS effectively. He also suggested that if these activities are continuously carried out the members will get closely connected with CRA.

The President and Members appreciated Mr.Sandeep Parmar, Vice President North for bringing in the activities which are need of the hour.

#### **Utilization of Property Fund for Purchasing a Property**

Mr.M S H Beg, Treasurer suggested that a reserve fund created for purchase of property is been laying ideal in the bank account and this can be utilized to purchase a property in the name of CRA. This shall reduce the cost of payment of monthly rent and if the property is adequate, it can also raise rent. He also said that an advertisement has been placed and the hunt for property is still in process.

#### **Establishment of Property Finalization Committee:**

Mr.M S H Beg, Treasurer suggested that a committee should be constituted which will oversee the various options for purchase of property and present the same to EC for approval.

#### EC Meeting to be done in Person



He also informed the members that his travel cost is borned fully by him and no travel bill will be claimed from CRA. He also appreciated Dr. S Chandrasekar, Vice President South for coordinating the meeting with various state chapters
