SUMMARY OF THE MINUTES

The Agenda of the meeting was to discuss about reply of the "SHOW CAUSE NOTICE" served upon Mr. Nihar Ranjan Panda, Director, Radio Gunjan, Odisha, one of the Life Member of CRA to the Chief Manager/Managing Director/CEO of United Bank of India, Gulmohar Park, New Delhi in which CRA has its account, levelling charges of misappropriation of funds against the three Office Bearers of CRA- President, Secretary General & Treasurer. Mr Panda also sent the copies of the letter to the Registrar of Societies and the Economic Offence Wing, Delhi Police. The President, Dr B.S.Panwar, shared the reply of the "SHOW CAUSE NOTICE" with the EC members and the letter was also read aloud for the understanding of the EC members. After discussion amongst themselves, The EC members felt that the explanation of the "SHOW CAUSE NOTICE" given by Mr Nihar Ranajan Panda has not been found satisfactory. He has not expressed any regret for his act of indiscipline. The EC members felt that strict

action should be taken against him. The EC members, unanimously, decided to expel Mr Nihar Ranjan Panda for a period of three years.

The following members approved of the Resolution passed during the EC meeting in the above context and authorised the President to serve the "EXPLUSION LETTER" to Mr Panda.

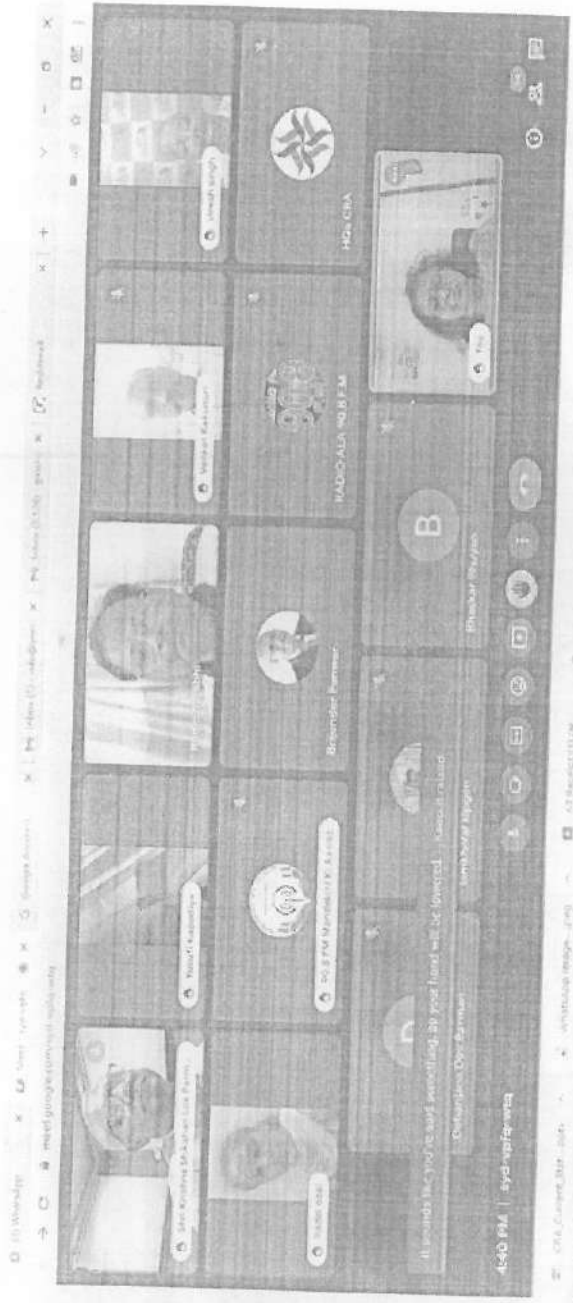

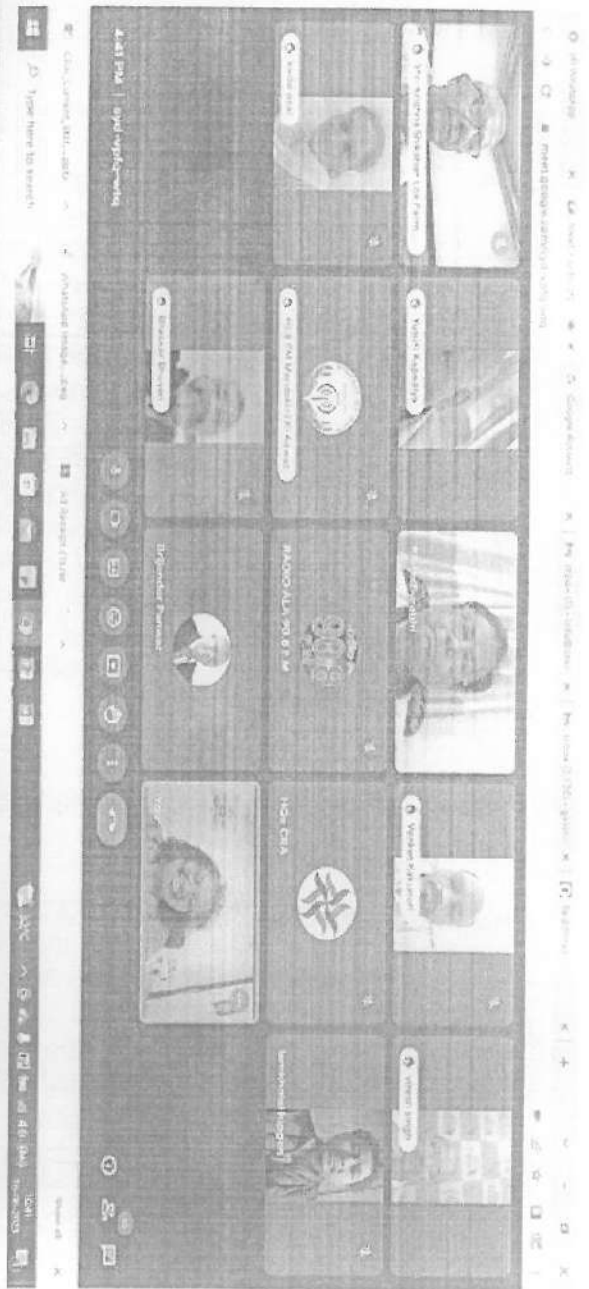
