Dr. Kandarpa Das, President welcomed the members present and briefed the members regarding activities during the last four months after the last Governing Body meeting during Sammelan. He also thanked NIOS for providing this opportunity to organize this meeting.

Agenda Item No. 1. Ms. Archana Kapoor, Treasurer presented a report regarding the latest status of the collection of annual membership fees. It has also been observed that 20 members did not clear their full membership fees i.e. Rs. 5000/- till date. After the discussion, it was resolved that a final request will be send to all those 20 members to deposit their dues (balance amount and the annual subscription) latest by 31st August, 2013. It was also resolved that all other members would be requested to clear their annual subscription for 2012-2013 & 2013-2014 latest by 31st August, 2013. The secretariat was asked to pursue the matter regarding membership fees and annual membership fees.

The members also discussed the issue of defaulter members participating in CRA elections process. It was opined that as per MOA only those members whose dues are cleared up to date are eligible for participating in the CRA elections. Hence, it is resolved that a general circular be issued to all members to clear their dues within 31st August, 2013 in order to make themselves eligible to participate in the elections 2014. A final list of members whose dues are cleared up to date will be prepared, which will serve as the final electoral roll for the CRA elections 2014. Members who fail to clear their dues by the stipulated date may pay their dues on a later date and continue their membership; however they shall not be eligible to participate (to elect or get elected) in 2014 elections. The secretariat has been asked to pursue the matter with all defaulting members by sending letters by emails and post and also over phone. All zonal Vice Presidents are also requested to pursue the matters in their respective zones.

Agenda Item No. 2. Ms. Archana Kapoor presented a report on the financial status of CRA for year 2012-13. She also informed the members that accounts for the three MIB sponsored consultations have already been submitted to the Ministry and it has been accepted. The audited report of the accounts would be circulated to the members soon.

Agenda Item No. 3. The Governing Body discussed the matter regarding setting up a Academy by CRA for organizing training and capacity building for the CR personnel in the country. Initially, the Academy may start organizing various activities for training and capacity building in collaboration with various academic institutions in the country and till than CRA Academy may function as a virtual academy. It is resolved that an amount of Rs. 4,00,000/- (Rupees four lakhs only) be reserved in a fixed deposit account in the Central Bank of India, Gulmohar park branch, New Delhi as a Corpus fund for the academy. Another surplus amount of Rs.1,50,000/- (Rupees one lakh fifty thousand only) will be put in fixed deposit for the CRA in the same bank immediately.



Agenda Item No. 4. Governing approved the decision of the President, CRA of allocating an amount of maximum Rs.25,000 to zonal chapters for various activities during 2012-2013. Since, only Southern zone and the eastern & north east zone (jointly) has requested for such allocation, it is resolved that fund may be allocated to the concerned zones only. From the next financial year, the allocation of funds will be as per provisions of the MOA, amended in February, 2013. After discussion, the Governing also resolved to approve the additional fund request of Rs. 10,000/- to the Southern zone as a special case. However, it is resolved that no request for additional fund shall be entertained by the Governing body in future and zonal chapters are requested to generate the additional fund requirement from local sponsors.

Agenda Item No. 5.The Governing resolved to initiate the process for the next elections to the Governing body immediately. As the first step in this direction, the defaulter members would be requested to clear their dues as resolved in Agenda item No. 1 and final electoral roll will be prepared and handed over to the Returning officer in October, 2013, who in turn would prepare the election schedule in consultation with the President. It is desired that the schedule be notified latest by December, 2013 and whole process is completed before the next Sammelan to be organized by the MIB. The Governing Body accepted the proposal of the President for appointing Dr. O. P. Dewal , Department of Communication and Journalism, IGNOU as the Returning Officer for the CRA elections 2014. The Governing Body also approved the following procedure to conduct the elections.

Step 1: Publication of the Draft Electoral roll by the CRA Secretariat.

Step 2: Consideration of request to amend anomalies in the electoral Roll by the Secretariat.

Step 3: Publication of the Final Electoral roll by CRA Secretariat

Step 4: Declaration of Election Schedule by the Returning Officer

Step 5: Invitation for nominations for the post of 6 Vice Presidents (one each from North, South, East, West, Central and North-east zones) and 16 Executive members of the Governing body (minimum one from each zone in order to ensure balanced representation).

Step 6: Scrutiny of nominations by the Returning Officer and declaration of valid nominations



Step 7: Conduct of elections by secret ballots by the Returning Officer

Step 8: Declaration of Results

AOB: The office bearers of various zones present complained that a lot of radio stations in their respective zones have not got their dues from DAVP. The secretariat was asked to get in touch with all the members regarding their dues from DAVP. The secretariat has also been asked to get in touch with DAVP for the payment of dues to CRA members

Ms. Archana Kapoor, Treasurer informed the members that in order to cut down expenditure the CRA secretariat has been reduced to one coordinator Ms. Sumati Thusoo with approval from the President.

The Board resolved that:

- Someone, preferably the President will have to give an explanation to the general body about why the information about the meeting post the Sammelan was not informed to the members 22 days in advance. Also the board has to inform as to why members were asked to leave when they arrived for the meeting on the scheduled time.
- 2. The GB meeting will be conducted every 3 months, either through skype or by hosting a meeting at a place convenient to majority of the members
- Hence forth any Chapter meetings/workshops/events must be organized and decided in consent with the Zonal Vice President and that the proposal will also have to be sent through the Zonal President. In case any financial support is to be received from CRA the protocol should be followed (sheet attached)
- The registration fee of Rs. 5000 will remain as a reserve and be held as a corpus fund only and will not be included in deciding the share of the Zone or State Chapters
- No TA/DA will be paid to any national body member, for any chapter/zonal meetings
- All programmes will use the a Standardized Logo of CRA for all its chapter meetings and reports etc
- 7. All CRA members can attend GB meetings as observers, provided they have paid both the registration and the annual membership fee
- 8. CRA will not allow dual membership in any other Indian organization

CRA can apply for membership to AMARC or any other international forum, organization if there is a direct benefit to the sector, there is a raise in the profile of CRA or in which there is no conflict of interest.
 If and when an official invitation comes in to CRA, the Secretary General/President will circulate the email within 48 hours to all the members/board. In case no one responds, then the Secretary General will use

his/her discretionary powers and nominate a station or an individual accordingly

11. In case of a meeting being attended by CRA board members, any one of the members shall be requested to represent CRA, and this should keep in mind the hierarchy of the organisation

to represent CRA in conferences/ or official meetings

- 12. All General body meetings should be announced 28 days in advance, with the venue and time circulated well in advance along with agenda- both through mail and hard copy.
- 13. All records and cheque books of CRA will stay in the Delhi Office. There will be no shifting of records or of the bank /auditors.
- 14. The Treasurer should take charge within 30 days of the posting of the minutes and will have to do all proposals, budgets, handle monetary issues, resolve issues of NEFT etc and also interact with the Ministry on issues of finances.
- 15. The Treasurer should be available when Ministry calls for budgets and discussions on the proposals submitted and for all discussions pertaining to the work of CRA.
- 16. All the elected members will have to observe and practice an ethical code of conduct in their own stations and projects. They will be very careful about the bills submitted or project protocols- as they will have to lead by example.
- 17. Tamilnadu Chapter be paid 25 % of the Rs 18000/- which had come as annual membership from TN/Puducherry members, which amounted to Rs 4500/-

- 11. Should a member repeatedly go public disregarding the GB quorum, three notices will be sent, following which an emergency GB meeting will be called and President can move a no confidence motion
- 12. The proposed monitoring system on community radios by BECIL was discussed and it was agreed that stations may agree to host the loggers on site
- 13. The GB members also decided to scrap the existing committees that were formed at the first GB with a request for new volunteers to head it as no work had been done so far.
- 14. Mr Braham Prakash agreed to manage the website. CRA Secretariat will get the website registered.
- 15. Also in case no body pitches and if a member works on different issues and takes initiative he/she should not be targeted
